## Background of Lisa Pang Foundation Limited (彭麗明慈善基金)

Lisa Pang Foundation Limited is an approved Hong Kong NGO and was founded by Lisa Pang who is a strong youth advocate who actively strives to make a positive impact in their lives. Lisa has already left a lasting legacy in the education industry as the first person to trademark her teaching methods 2-sided Debate™ in China, as well as Decoding™ and Projection™ in Hong Kong. Her methods have been widely-acclaimed in the media and continue to be the backbones of success for top scholars in Cambridge, Oxford, Harvard, Stanford, and other top universities worldwide today. Lisa's passion for people has also inspired her to spearhead poverty alleviation initiatives and lead the strategic growth of her non-profit organisation, Lisa Pang Foundation Ltd, which she founded in 2019. Through her successful campaigns like 'Have You Eaten Rice Yet'™—based on an Asian-based phrase that she became the first person to trademark and add to the Urban Dictionary (US) in 2021—she hopes to transform communities by spreading kindness, unity, and peace.

## Have You Eaten Rice Yet?™ (你食咗飯未?) (2018 to present)

In 2018, Lisa founded and trademarked the culturally-astute Have You Eaten Rice Yet?™ global initiative to spread kindness, compassion, unity, and peace worldwide. Drawing on her excellent relationship-building and communication skills, she has since led many endeavours with the underlying mission to empower the community, foster diversity, and raise awareness on crucial issues that affect our planet, including:

- Launching the Have You Eaten Rice Yet?™ T-shirt fundraising campaign with 'Ground Zero' brand founder and top international fashion designer for celebrities such as Angelababy and Rita Ora, Mr. Eri Chu. In demonstrating a strong aptitude for business development, proceeds from the campaign went to the charitable distribution of food for the New Home Association HK (新家園協會) and Food Angel (惜食堂) non-profit organisations.
- Organising a food event at the Vision First Refugee Camp by engaging in a community partnership with global fast-food chain Yoshinoya, where Chairman of Hong Kong-listed company Hop Hing Group and Yoshinoya, was the main sponsor and donor of all the rice boxes.
- Being the first person in the world to trademark the Asian-based phrase 'Have You Eaten Rice Yet?'™ and adding it to the Urban Dictionary (US)
- Collecting over 600 video messages of goodwill from all 94 MTR stations in Hong Kong at the start of the first COVID-19 outbreak to uplift the spirits of the community
- Appointing 6 Campaign Ambassadors and 5,000 volunteers from 118 countries around the world to spark change and bring the international community together for a great cause.
